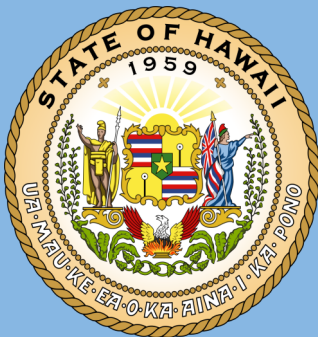

Relevant Bills

Red Hill Water Contamination

- **HB906** — requires an audit of the state's surface water transmission systems
- **HB1079** — increases oversight by the Director of Health to enforce water quality certifications
- **HB1511** — provides resources to the Board of Water Supply to create new wells and shafts

Government Ethics and Transparency

- **HB89** — prohibits the acceptance of campaign contributions during the legislative session
- **HB90** — requires fundraiser notices regardless of the amount of the ticket price
- **HB93** — allows the publishing names of committees that fail to file timely campaign spending reports
- **HB99** — limits cash campaign contributions to candidate committees

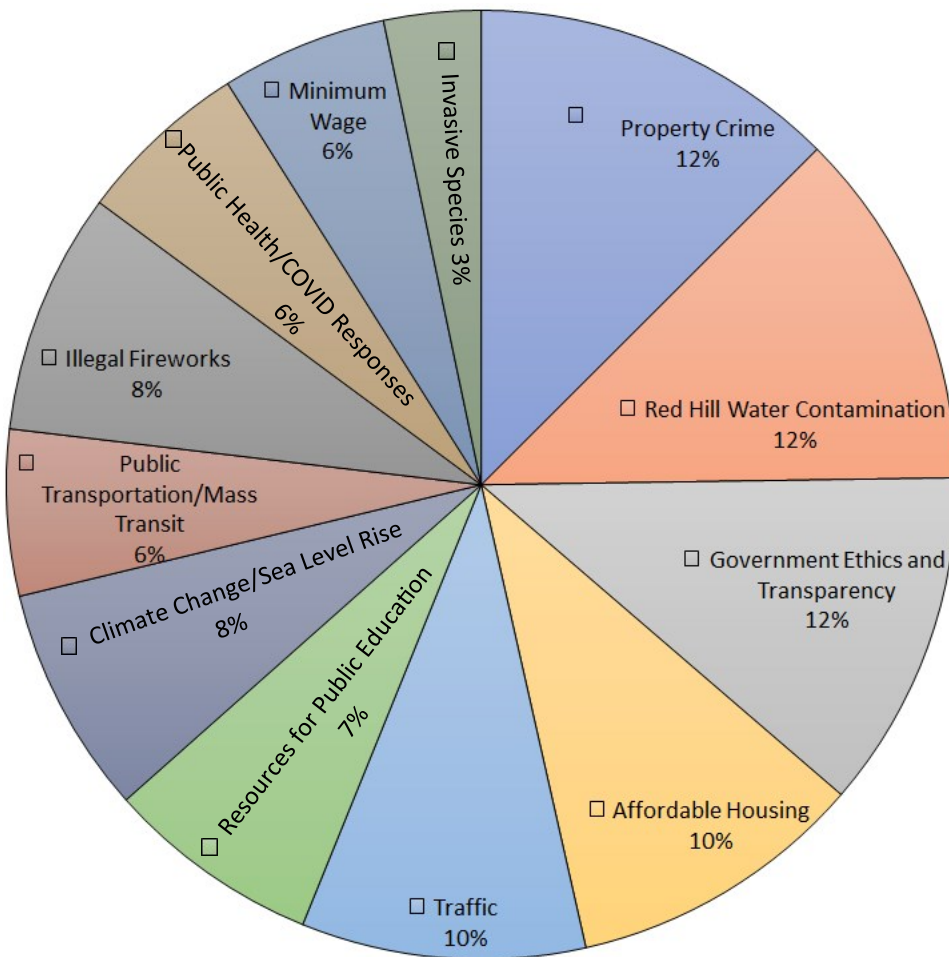
Affordable Housing

- **HB280** — prohibits the purchase of property by non-resident aliens
- **HB1185** — provides resources for planning statewide transit oriented development projects

Other Priorities

- **HB936** — requires financial literacy in the personal transition plan requirement for public school students
- **HB1301** — conducts a study on the social determinants of health of Native Hawaiians, Pacific Islanders, and Filipinos

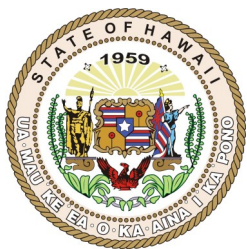
